# 1. Aims

Our school aims to meet its obligations under the public sector equality duty by having due regard to the need to:

- Eliminate discrimination and other conduct that is prohibited by the Equality Act 2010
- Advance equality of opportunity between people who share a protected characteristic and people who do not share it
- Foster good relations across all characteristics between people who share a protected characteristic and people who do not share it

# 2. Legislation and guidance

This document meets the requirements under the following legislation:

- The Equality Act 2010, which introduced the public sector equality duty and protects people from discrimination
- The Equality Act 2010 (Specific Duties) Regulations 2011, which require schools to publish
  information to demonstrate how they are complying with the public sector equality duty and to
  publish equality objectives

This document is also based on Department for Education (DfE) guidance: <u>The Equality Act 2010 and schools.</u>

# 3. Roles and responsibilities

The governing board will:

- Ensure that the equality information and objectives as set out in this statement are published and communicated throughout the school, including to staff, pupils and parents, and that they are reviewed and updated at least once every four years
- Delegate responsibility for monitoring the achievement of the objectives on a daily basis to the Head of School

The equality link governor is Carrie Mandeville. They will:

- Meet with the designated member of staff for equality every seasonal term (Head of School) and other relevant staff members, to discuss any issues and how these are being addressed
- Ensure they are familiar with all relevant legislation and the contents of this document
- · Attend appropriate equality and diversity training
- Report back to the full governing board regarding any issues

#### The Headteacher will:

- Promote knowledge and understanding of the equality objectives amongst staff and pupils
- Monitor success in achieving the objectives and report back to governors

#### The Head of School will:

- Support the Headteacher in promoting knowledge and understanding of the equality objectives amongst staff and pupils
- Meet with the equality link governor every seasonal term to raise and discuss any issues
- Support the Headteacher in identifying any staff training needs, and deliver training as necessary

All school staff are expected to have regard to this document and to work to achieve the objectives as set out in section 8.

# 4. Eliminating discrimination

The school is aware of its obligations under the Equality Act 2010 and complies with non-discrimination provisions.

Where relevant, our policies include reference to the importance of avoiding discrimination and other prohibited conduct.

Staff and governors are regularly reminded of their responsibilities under the Equality Act, for example during meetings. Where this has been discussed during a meeting it is recorded in the meeting minutes.

New staff receive the Equality Statement and Objectives as part of their induction.

The school has a designated member of staff for monitoring equality issues, and an equality link governor. They regularly liaise regarding any issues and make senior leaders and governors aware of these as appropriate.

# 5. Advancing equality of opportunity

As set out in the DfE guidance on the Equality Act, the school aims to advance equality of opportunity by:

- Removing or minimising disadvantages suffered by people which are connected to a particular characteristic they have (e.g. pupils with disabilities, or gay pupils who are being subjected to homophobic bullying)
- Taking steps to meet the particular needs of people who have a particular characteristic (e.g. enabling Muslim pupils to pray at prescribed times or fasting for Ramadan)
- Encouraging people who have a particular characteristic to participate fully in any activities

In fulfilling this aspect of the duty, the school will:

- Adhere to statutory guidelines and publish the school performance outcomes on the website each academic year showing how pupils with certain characteristics are performing (SEN, Pupil Premium, Gender)
- Analyse pupil data to determine strengths and areas for improvement, implement actions in response and publish this information

• Make evidence available identifying improvements for specific groups

# 6. Fostering good relations

The school aims to foster good relations between those who share a protected characteristic and those who do not share it by:

- Promoting respect, friendship and understanding of a range of religions and cultures through
  different aspects of our curriculum. This includes teaching in RE, personal, social, health and
  economic (PSHE) education and RSE (using Jigsaw resources), but also activities in other curriculum
  areas. For example, as part of teaching and learning in English/reading, pupils will be introduced to
  literature from a range of cultures
- Holding assemblies dealing with relevant issues. Pupils will be encouraged to take a lead in such assemblies and we will also invite external speakers to contribute
- Working with our local community. This includes inviting leaders of local faith groups to speak at assemblies, and organising school trips and activities based around the local community
- Encouraging and implementing initiatives to deal with tensions between different groups of pupils
  within the school. For example, our school council has representatives from different year groups
  and is formed of pupils from a range of backgrounds. All pupils are encouraged to participate in the
  school's activities, such as sports clubs. We promote knowledge and understanding of different
  cultures within he wider school community through our school newsletter and social media
  platforms.

# 7. Equality considerations in decision-making

The school ensures it has due regard to equality considerations whenever significant decisions are made.

The school always considers the impact of significant decisions on particular groups. For example, when a school trip or activity is being planned, the school considers whether the trip:

- Cuts across any religious holidays
- Is accessible to pupils with disabilities
- Has equivalent facilities for boys and girls

The school keeps a written record (known as an Equality Impact Assessment) to show we have actively considered our equality duties and asked ourselves relevant questions. This is recorded at the same time as the risk assessment when planning school trips and activities. The record is completed within the risk assessment by the Health and Safety Officer, and is stored electronically.

# 8. Equality objectives

Objective 1: Curriculum. Ensure all children have full access to all aspects of a curriculum that represents the diversity of our school and beyond.

Objective 2: Culture. To celebrate and raise the profiles of different cultures from across our school through mediums such as assemblies, discussions, PSHE, visits.

Objective 3: Community. To develop links with the local community and groups from diverse backgrounds.

Objective 4: Characteristics (protected. To ensure all stakeholders treat each other as equals through an inclusive and welcoming environment.
