Introduction

The governing body of St Chad's CE and Nursery Primary School applies the regulations on admissions fairly and equally to all those who wish to attend his school. The school standards and Framework act 1998 introduced a new framework for school admissions as of September 2000. This policy conforms to the regulations that are set out in that Act and also further explained in the statutory School Admissions code of Practice and the Statutory Appeals Code of Practice.

Aims and Objectives

We are an inclusive school that welcomes children from all backgrounds and abilities. All applications will be treated on merit and in a sensitive manner.

The only restriction we place on entry is that of number. If the number of children applying for entry exceeds the places available, we enforce the procedure set out below in order to determine whether a child is accepted or not. It is our wish to allow parents the right to have a place at the school of their choice. However, this is not always possible, due to the excess demand on the school places available. The level of ability of a child or any special needs that s/he may have plays no part in the admissions policy of this school.

How parents can apply for their child to be admitted to our school.

As our school is a Church Controlled school the Local Authority (LA) is therefore the 'Admissions Authority' for the school. The regulations for entry to each school, where the Admissions Authority is the LA are published each year by the LA. Parents can receive a copy of these regulations directly from the LA.

The LA publishes a composite admissions prospectus each year, which gives information about how parents can apply for a place in the school of their choice. Parents have a right to express a preference for the school of their choice and they should do so on the application form. Expressing a preference does not, in itself, guarantee a place at this school. Application forms can be obtained from the Education Department of the LA and should be completed by the date stipulated on the forms. The LA notifies parents about the school place as soon as all the applications have been considered. In this

area children enter school in the academic year they become five. There is one admissions date per year, early in September (i.e. at the start of the school year). Therefore, parents who would like their child to be admitted to this school during the year their child is five should ensure that they complete the necessary application form by the due date.

Transfers and In-Year Admissions

A parent moving into the area or wishing to transfer a child from another local school should obtain an application form from the school or apply online via the LA website as above.

Should a place be available in the appropriate year, an offer of the place will be made by the school.

Admission appeals

If your child is not offered a place at this school, it is because to do so would prejudice the education of other children by allowing numbers in the school to increase too much.

If parents wish to appeal against a decision to refuse entry, they can do so by applying to the LA. An independent appeals panel then meets to consider all appeals by parents who have been refused a place at our school and who wish to appeal against this decision. An appeals panel's decision is binding for all parties concerned. If the appeals panel decides that we should admit a child to our school, then we will accept this and continue to do all we can to provide the best education for all the children at our school.

Planned admission limit

The planned admission limit is the number of children the school can accommodate in each year group. The planned admission limit for our school is 30 children. We keep this number under review and the governors will apply to change the number if circumstances allow.

Infant Class Size

We teach infant children (age 4-7) in classes that have a maximum number of 30 children.

Nursery Class Size

Our school nursery takes children from the ages 3-4, each session has a maximum of 26 three and four year olds.

Review

The policy will be reviewed annually with the Admissions Authority in the light of any changed
