* The Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body and Staff Governors are elected by the staff body of the school.

** All Governors’ terms of office are 4 years.

The Governing Body appointed a Pay Committee, a Resources Committee and a Standards & Safeguarding Committee in September 2025-26 – other appeals committees will be appointed as and when required.

The Full Governing Body ratifies decisions following recommendation from the committees/panel above (unless otherwise stated in School Policy/Terms of Reference/Scheme of Delegation), and all minutes are available on application to the school with the exception of confidential minutes.

The Governing Body have not appointed any Associate Governors for the Academic Year 2025-26.
