

# Living in the Wider World - One World

PSHE and Citizenship | UKS2 | Planning Overview

## About the Topic

This unit is based on the concept that we all have a responsibility to live as global citizens. It is inspired by the idea that we all have a responsibility to help the environment and all living things throughout the world through the choices we make. It aims to enable the children to explore the ideas of sustainability, the use of the earth's natural resources and the harmful effects of global warming. In this unit, children also learn about the steps they can take to reduce these harmful effects. They will also learn about biodiversity and its importance and explore what they would like to do to make the world a better place.



## Home Learning

**What Is Living and Growing There?** In this activity, the children choose a habitat from those given and research the biodiversity of it. They find out why it is important that the habitat they have chosen remains diverse and what can be done to protect it.

**Going for Global:** In this activity, the children design and make a poster to encourage others to be good global citizens. They think about what can be done to fulfil this role and explain why it is important.



## Wider Learning:

Organise and hold a 'Water Week' where children explore the use of water throughout the world, the effects of wasting it and how we can use it responsibly. Explore and use a range of these [Water Week Resources](#).

## Assessment Statements

- begin to analyse their decisions and choices to a greater depth.
