## **Teign School Accessibility Plan 2025-26**



## Aims to:

- Increase the extent to which disabled pupils can participate in the curriculum;
- Improve the physical environment of schools to enable those with disabilities to take better advantage of education, benefits, facilities and services provided;
- Improve the availability of accessible information to those with disabilities, including parents, carers and students.
- This plan sets out the practical accessibility of the site and should be used in conjunction with the SEND Policy to support children with disabilities

## **Current position:**

- Toilets for disabled students to access in all the main buildings: opposite canteen;
   sports area; back of theatre; science block;
- Lifts in K Block, L Block, J Block, S Block providing access to different buildings
- Ramp created to provide a route around the site (back of J block);
- Automated doors in some blocks;
- Disabled parking spaces in the car park;
- Students with physical disabilities able to leave lessons a few minutes early to provide a quieter environment between lessons change-overs;
- Inclusion team, work with external specialists for advice re additional auxiliary aids and site accessibility;
- Inclusion team and wellbeing staff support a range of vulnerable pupils and their families:
- Learning Coaches support a range of pupils in lessons, through interventions and on school trips (including residential);
- Full-time First Aiders are accessible to students at all times of school day in Student Support;
- CPD provided for staff re areas of need;
- Pupil Profiles with background information and strategies to support students;
- Reduced timetables and rest breaks where needed;
- Access arrangements where needed;
- Provision of enlarged formats for students with visual impairment and coloured paper/booklets;
- Access to Inclusion Area;
- SEND Information Report on the website
- SEND audit completed to identify staff CPD needs.
