INTRODUCTION

The Local Authority must consult on changes to its admission arrangements. Where no changes are proposed to either its Coordinated Admissions Schemes or its Admission Arrangements for Community and Voluntary Controlled schools, there is no requirement to publicly consult. (Full consultation took place in Autumn 2018 - within the 7 years limit set by the School Admissions Code.)

For September 2025 entry to Community or Voluntary Controlled Schools, the Local Authority is not proposing any changes to its Admission Arrangements (or Coordinated Admissions Schemes) therefore, there is no requirement to publicly consult. However, the Local Authority must still consult Community and Voluntary Controlled schools where it proposes to either increase or keep the same Published Admission Number.

Details of the proposed PANs for Community and Voluntary Controlled schools are attached at Appendix 1.
